RESOLUTION TO CALL FOR SPECIAL ELECTION

TO ORDER A SPECIAL ELECTION TO FILL THE VACANCY IN THE OFFICE OF COUNCILMEMBER OF THE CITY OF WINTERVILLE, GEORGIA, CREATED BY THE RESIGNATION OF GARY A. SNOW; TO FIX THE QUALIFYING FEE AND PERIOD FOR QUALIFYING FOR SAID OFFICE; TO AUTHORIZE THE BOARD OF ELECTIONS OF ATHENS-CLARKE COUNTY, GEORGIA, TO PERFORM ALL DUTIES AS SUPERINTENDENT OF ELECTIONS ASSOCIATED WITH SAID SPECIAL ELECTION AND RUNOFF, IF ANY, AS SET FORTH IN THE CONTRACT FOR ELECTION SERVICES FOR MUNICIPALITIES LOCATED WITHIN ATHENS-CLARKE COUNTY, GEORGIA AND PURSUANT TO THE OFFICAL CODE OF GEORGIA ANNOTATED, SECTION 21-2-45(C).

WHEREAS, in the general election conducted on November 2, 2021, Gary A. Snow was elected to service as Councilmember of the City of Winterville for the term of (4) years beginning January 3, 2022; and

WHEREAS, on March 31, 2022, Gary A. Snow resigned from City Council of the City of Winterville;

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE GOVERNING AUTHORITY OF THE CITY OF WINTERVILLE, GEORGIA, THAT;

Section 1. A Special Election shall be held in the City of Winterville, Georgia to be conducted by the Athens-Clarke County Board of Elections on Tuesday, November 8, 2022 for the purpose of electing a Councilmember of the City of Winterville, Georgia, to fill the vacancy created by the resignation of Gary A. Snow for the remainder of Gary A. Snow's unexpired term which expires on December 31, 2025.

Section 2. The qualifying fee for the office of Councilmember of the City of Winterville in said Special Municipal Election shall be \$72.00.

Section 3. The period in which candidates must qualify for the vacated office of Councilmember of the City of Winterville in said Municipal Election shall be August 1, 2022, and ending Wednesday August 3, 2022. Hours to qualify for said office shall be from 9:00 a.m. until 5:00 p.m. on Monday August 3, 2022 and Tuesday August 2, 2022. The deadline for qualifying to vote in the Special Municipal Election for the office of Councilmember of the City of Winterville shall be noon on Wednesday August 3, 2022.

Section 4. Pursuant to the authority of the Official Code of Georgia Annotated, Section 21-2-45(c), the Athens Clarke County Board of Elections, Athens Clarke County, Georgia is hereby authorized to conduct said Special Municipal Election and runoff, if any, and in conducting thereof shall perform all duties of the superintendent of elections with the exception of qualification of candidates as agreed in that Contract for Election Services for Municipalities located within Athens

Clarke County, Georgia by and between the City of Winterville, Georgia and the Athens Clarke County Board of Elections dated February 10, 1999.




